**The Pediatric Advanced Life Support
through UVA's Life Support Learning Center:**

The PALS Provider Course is designed to provide participants with the information needed to recognize infants and children at risk for cardiopulmonary arrest, strategies to prevent arrest, and the cognitive and psychomotor skills needed to resuscitate and stabilize those in respiratory failure, shock, or cardiopulmonary arrest. Participants are required to have a current CPR card. The following course card is accepted: American Heart Association -Healthcare Provider (HCP). BLS re-certification is available on the day of the course with online advance preparation. \$60 for non-UVA employees (includes course access and a skill session), free for UVA employees.
